## CIRCULAR SCHEME PARTICIPANTS

### Coronavirus (SARS-CoV-2)

#### Extension of the eligibility of delivery of all QS-certified sites

Dear Sir or Madam,

due to the current spread of the coronavirus, the **eligibility of delivery of all QS-certified sites (incl. QS-GAP) will be extended by two months** (changeover in the QS database on March 26<sup>th</sup>, 2020).

This procedure has been approved by the QS advisory boards.

According to the extended QS eligibility of delivery, necessary QS audits can be postponed to a later date (see also our letter of March 20<sup>th</sup>, 2020).

If, despite the current situation, QS audits are to be carried out, it is still the case that they will only be carried out if both, the company and the auditor, **have agreed** to the audit being implemented. Again, we strongly recommend that audits should not be carried out at this time.

The measures communicated by us in our letters of March 10<sup>th</sup> and 20<sup>th</sup> 2020 remain valid.
